**Subject: Grant of Accreditation to Five (05) Primary Health Care Centres (PHCCs) and Polyclinics by National Health Quality & Accreditation Council (NHQAC) – regarding.**

**Sir/Madam,**

1. The proposals for accreditation of Primary Health Care Centres (PHCCs) and Polyclinics, duly assessed and evaluated by **National Health Quality & Accreditation Council (NHQAC)**, were placed before the **Accreditation Committee of NHQAC** for consideration and approval in its meeting held on **13 December 2025** at NHQAC Headquarters.

2. The Accreditation Committee examined the accreditation proposals and **accorded approval** to the following PHCCs / Polyclinics, which were found to be **conforming to NHQAC Quality, Safety, Infrastructure, Clinical Service and Governance Norms**.

3. The accreditation granted above is **subject to the following conditions:**

- i. The accreditation shall be valid for a period of **three (03) years and five (05)** from the date of issue of this order.
- ii. The accredited Primary Health Care Centres (PHCCs) and Polyclinics shall **strictly and continuously comply with all NHQAC Quality Standards, clinical service protocols, patient safety norms, infection control guidelines, infrastructure requirements, human resource norms, record-keeping systems and ethical medical practices**, as notified or amended by NHQAC from time to time.
- iii. The accredited institutions shall ensure that **no deviation, dilution or violation** of the prescribed standards is permitted during the entire validity period of accreditation, and shall remain fully responsible for maintaining the **quality, safety and reliability of healthcare services** being provided to patients and the general public.
- iv. NHQAC shall have the **unrestricted right to conduct periodic inspections, surprise inspections, audits, monitoring visits or re-assessments**, either directly or through its authorized assessors, at any time during the validity period of accreditation, for the purpose of verification of continued compliance.
- v. The accredited institutions shall extend **full cooperation**, provide unhindered access to premises, records, registers, patient data (as permissible under law), staff and infrastructure, and shall not obstruct or influence the assessment or inspection process in any manner whatsoever.
- vi. This accreditation shall be treated strictly as a **quality assurance and accreditation recognition** and shall **not be construed as a license, statutory registration, medical practice authorization or legal entitlement** beyond what is permissible under the prevailing laws, rules and regulations
- vii. The accredited Primary Health Care Centres (PHCCs) and Polyclinics shall ensure that the **NHQAC accreditation status, certificate number and validity period** is displayed prominently at the reception / entrance area of the institution and are not misrepresented, exaggerated or used in a misleading manner in any form of communication, publicity or advertisement.

viii. The accreditation granted by NHQAC shall be **non-transferable** and shall remain valid **only for the specific premises, location, ownership, management structure and scope of services** assessed at the time of accreditation. Any change therein shall be promptly reported to NHQAC for review and approval.

ix. In the event of receipt of any **complaint, adverse report, incident of gross negligence, patient safety breach, or violation of prescribed standards**, NHQAC shall be competent to initiate appropriate proceedings including **review, suspension, withdrawal or cancellation** of the accreditation, after following due process as deemed appropriate by the Council.

x. The accredited institutions shall acknowledge that **NHQAC shall not be liable** for any medical, legal, financial or administrative consequences arising out of the services rendered by the institution, and that the entire responsibility for compliance with applicable laws, patient care and service delivery shall rest solely with the concerned PHCC or Polyclinic.

4. This order is issued with the approval of the **Competent Authority, NHQAC** and shall come into force with immediate effect.
